 - D. Krog/Bilgrien nominated Becky Denzine for Treasurer. Motion (Krog/Van De Voort) to close nominations and have the secretary cast a unanimous vote for Becky Denzine as Treasurer. Motion carried.
 - E. Evan Lund was appointed the CESA #12 Delegate. Jon Pesko was appointed as the WASB Delegate.
 - F. The Board president, clerk, and treasurer were designated as check signers for the district.
 - G. Motion (Krog/Bilgrien) to designate the Price County Review as the district newspaper. Motion carried 7-0.
 - H. President Pesko will review committee assignments. Board members interested in specific assignments should contact President Pesko.
