Students in the School District of Phillips shall have an opportunity to participate in school lunch and milk programs. These programs shall be administered by the superintendent, or designee, in accordance with established guidelines.

Food service prices shall be established by the Board annually. In accordance with federal guidelines, the District shall offer free and reduced price food services to students who qualify.

Individual student account balances will be reviewed on a case-by-case basis. The director of food service in partnership with the building administration office staff will prepare a monthly report of all negative balances to the superintendent's office. Negative balance accounts determined to need communication will receive written notice of the account statement which will include the contact person assigned for assistance. Students in grades 4K - grade 8 will continue to receive school-provided meals during the process of review. Students in grades 9-12 may be denied access to school-provided meals only by the superintendent or his/her designee.

Vending machines may be installed in District schools when approved by the Board.

The School District of Phillips shall not discriminate in school-sponsored food service programs on the basis of sex, face, religion, national origin, ancestry, creed, pregnancy, marital or parental status, sexual orientation, physical, mental, emotional or learning disability, or handicap.

# Grant Writer's Report – July 17, 2017 Dale Houdek

The following information represents activity relating to grant exploration/application from March 20 through June 30, 2017:

**Fab Lab Grant:** As you are aware, we received the Fab Lab grant for \$25,000. At this time it appears that there will be another opportunity to apply for another grant of similar nature later this fall. I would recommend that we reapply for this grant to add to our already existing resources.

**AODA Grant:** The school district was sent notice just recently that we were awarded this grant which I submitted in mid-April. The award is for \$15,000 dollars a year for the next two years for a total of \$30,000. About 2/3 of the grant will be used to hire a district-wide AODA coordinator who will be responsible for developing K-12 activities related to alcohol and drug abuse. Although, data indicated that there was a very small percent of the district's student population that had been involved in drug/alcohol use, statistics revealed a tremendous increase in AODA abuse by the adult community, many of whom were parents. The focus on the district's K-12 students was on mental health activities.

**Future Grant Opportunities:** As I reported in March, "Hot Spot" grant funding related to broadband deficiencies may be coming in the 2017-18 school year. With the development a new State budget other opportunities may also become available. I am still considering staff requests regarding a community splash pad, funding for extra-curricular activities and a community garden while continuing to research other potential grant sources.

**End-of-Year Reports:** I did complete the end-of-year report for last year's School Forest grant and am still in the process of submitting the final reports for the Financial Literacy grant.

I would be willing to extend the grant writer's contract with the district for another year.

Also present was Superintendent Morgan; District Financial Manager Lehman; Principal Hoogland; Director of Maintenance Berens; Ms. Seelig, Ph.D.; and other members of the community.

- A. Presentation by Ms. Jennifer Seelig Ph.D. "An Ethnographic Study of a School-Community Relationship in Rural Wisconsin" -See Research Brief along with Recommendations and Resources
- B. Loggers United Booster Club
  - 1. Proceeds from the wild game feed in the amount of \$10,000 is being donated back to the School District of Phillips.
  - 2. The Club is hoping to work with the Board to identify sponsorship benefits for the football score board.
  - A survey conducted on proposing athletic fees with a step-down or subsidized by the club showed that parents weren't interested in either proposal. The survey did show a concern about the late bus being discontinued and what would it take to bring back this service.

Ms. Lehman presented the adjustments that are shown on the two handouts followed by a discussion by the committee. Motion (Willett/Marlenga) to approve the amendments of the 2016-2017 budget as presented. Motion carried 7-0.

- V. Proposed Preliminary Budget for 2017-2018 School Year See attached proposal which was reviewed by Ms. Lehman. Discussion followed. The preliminary budget will be on the agenda Monday night for the full Board to consider for approval.
- VI. Additional Compensation Plan
  - A. Changes proposed by the LCT were reviewed.
  - B. If point value for credits earned is to be changed, it would not become effective until the 2018-2019 school year so teachers are able to plan.
  - C. Primary goal is sustainability. Adjustments will be partially dictated by budget.

- 3. Phase I of the project to include opening of wall between classrooms and electric for innovation lab can begin but not to exceed \$22,000.00 without further discussion.
