

**Board Meeting Update  
May 20, 2013**

**Student Information:**

**The following items were approved in open session by the Board of Education on May 20, 2013:**

- 1) Dental insurance will be renewed with Delta Dental. Employees will pay 20% of deductible (unless otherwise specified in Employee Handbook) and some items previously covered at 100% will be 80%. The \$1,000 individual amount will remain at \$1,000.00. Total monthly premium: \$44.68/single; \$118.52/family.
- 2) Health Insurance will be renewed with Security Health. Employees will pay 20% of deductible (unless otherwise specified in Employee Handbook). The deductibles will remain \$3,000/\$6,000 with a Board paydown to \$250/\$500. A \$1,000/\$2,000 drug card (\$10/\$30/\$60) has been added after the deductible is met with the employee paying the first \$500/\$1000 and the Board covering the remaining \$500/\$1000. Total monthly premium: \$614.99/single; \$1,395.92/family. Meetings will be held with employees next week to answer any questions on dental and health insurance changes.
